### **THE VENETIAN TATTOO GATHERING VENDOR PACKET APPLICATION RULES**

Thank you for applying for a booth at THE VENETIAN TATTOO GATHERING. Here are some simple guidelines to make everything nice and easy in getting your space at the VTG! Please read all of the forms carefully. Be sure to complete all forms thoroughly. Incomplete forms, missing or partial payment or late applications will be rejected. There are no exceptions to these rules!

### **PLEASE READ - THIS IS VERY IMPORTANT !**

- ALL BOOTHS MUST BE PRE-APPROVED!
- IN ORDER TO PURCHASE A BOOTH YOU MUST HAVE RECEIVED AN OFFICIAL VTG INVITATION!
- THE VENETIAN TATTOO GATHERING IS INVITATION ONLY. BOOTH SALES ARE FIRST COME, FIRST SERVE AFTER INVITES ARE SENT.
- IN ORDER TO SOLIDIFY YOUR BOOTH AT THE VENETIAN TATTOO GATHERING, YOU MUST COMPLETE ALL REQUIRED FORMS AND FEES.
- IF BOOTH PAYMENT AND FORMS ARE NOT RECEIVED 60 DAYS PRIOR, YOUR BOOTH WILL BE MADE AVAILABLE OTHERS.
- BOOTHS ARE SINGLE BOOTHS
- UPON ACCEPTING EACH APPLICATION, THE VENETIAN TATTOO GATHERING WEBSITE WILL ADD THE ARTIST INFORMATION AND LINKED THUMBNAIL TO THE ATTENDING ARTISTS SECTION. THIS WILL ALLOW ATTENDEES AND OTHER ARTISTS TO EASILY VIEW WHO IS WORKING AT THE VENETIAN TATTOO GATHERING.
- YOU WILL NOT BE ABLE TO TATTOO AT THE VENETIAN TATTOO GATHERING IF YOU DO NOT HAVE YOUR BLOODBORNE PATHOGENS TRAINING.

• THE BOARD OF HEALTH REQUIRES THAT ALL ARTISTS HAVE ALL TRAINING RECORDS PRESENT AT THE FESTIVAL.

• Keep in mind, we do NOT take deposits, booths must be paid in full in order to finalize your booth along with your completed vendor release form. If your payment and forms are not received within 60 days of your invitation, your booth will be given to the next available artist and your payment will be returned! Your booth is not solidified until payment and forms have been received. No exceptions!

Before tattooing, painting or vending an application will be processed and the application must be fully completed. Failure to complete this application will result in not having your booth reserved. Before attending the Venetian Tattoo Gathering you must complete the Event Information and Applicant Information sections below no later than 60 days prior to THE VENETIAN TATTOO GATHERING! NO EXCEPTIONS!

I, do for myself, studio, and associates, as well as any and all clients, do hereby release, forever discharge and agree to hold harmless the THE VENETIAN TATTOO GATHERING. and the Hotel in which the event is held and the directors, agents, servants, contractors, and employees from any and all liability, claims, or demands for personal injury sickness or death, as well as property damages and expenses, of any nature whatsoever which may be incurred by the undersigned that occur while said is participating in this event. Furthermore, I hereby assume all risk of personal and client injury, sickness, death, damage and expense as a result of participation in this event.

I agree to examine and follow all pertinent laws, statutes, ordinances, rules, and regulations by the state and THE VENETIAN TATTOO GATHERING. I am responsible for all costs and liabilities arising from the use of patented, trademarked, copyrighted or serve mark materials, equipment, processes or creative rights. I agree to make every client being tattooed, pierced and/or obtaining body modifications of any kind at THE VENETIAN TATTOO GATHERING to complete a release form before performing any modification services on any client.

Only THE VENETIAN TATTOO GATHERING will display, license, sell and merchandise all event items. THE VENETIAN TATTOO GATHERING has the authority to approve or disapprove of all displays, promotions, sales, or merchandising of the products or services presented by me. Any of these things that are disapproved of by the THE VENETIAN TATTOO GATHERING will be removed from the premises and may be expelled from the event.

Illegal drugs, controlled substances, weapons, and racially or sexually offensive merchandise will not be permitted at this event.

I cannot sell, give or offer for sale any pictures or accounting of this event for publication without the written permission of THE VENETIAN TATTOO GATHERING. This includes any interviews or photo sessions not supplied by the THE VENETIAN TATTOO GATHERING.

I am responsible for any and all taxable sales of services or products sold at this event.

THE VENETIAN TATTOO GATHERING reserves the right to terminate the license/contract granted by this agreement for good cause and in said event, I agree to waive and forego all claims for damages and recourse of any kind.

## **THE VENETIAN TATTOO GATHERING - NEEDLE AGREEMENT**

In order to comply with federal, state, and local regulations, the following protocol must be adhered to for contaminated sharps and regulated waste disposal.

1. All tattoo needles must be disposed of immediately after use into the regulated sharps container that has been provided for you. The entire needle/needle-bar configuration must be disposed of as a single-unit. DO NOT break, bend, or remove the needle configuration from the bar under any circumstance. To do so is a violation of federal law.
2. Disposable razors must also be disposed of directly into the sharps container. DO NOT dispose of razors into the general trash. DO NOT break, bend, remove, or re-cap the head of the razor under any circumstance.
3. All sharps containers must be maintained in an upright position throughout use.
4. DO NOT allow the sharps container to overflow. If a replacement is needed, please contact Durb Morrison or other authorized staff member.
5. Upon reaching the "fill" line, close & lock sharps container lid. Seal with duct tape or any sealable tape.
6. At the end of the show, close & lock sharps container lid. Seal with duct tape.
7. Cleaning contaminated equipment in public restrooms or private hotel rooms is STRICTLY PROHIBITED! Anyone discovered rinsing, scrubbing, or cleaning contaminated equipment on hotel/convention center grounds will be required to leave the premises immediately. No refunds will be given.
